# 5. MEDICAL LABORATORY TECHNOLOGIST III - TEN (10) POSTS - (JOB GROUP CPSB 11)

- xi. Have knowledge of general safety and quality assurance procedures.

- ix. Satisfy the requirements of Chapter 6 of the Constitution of Kenya.
- x. Have good organizational skills.
- xi. Have the ability to foster a good working environment conducive to excellent customer service.
- xii. Have knowledge of general safety and quality assurance procedures.

- ii. Nursing care prior to and following specialized surgery.

- v. Assessing, planning, implementing nursing interventions and evaluating patient's outcomes.
- vi. Diagnosing common health conditions.
- vii. Referring patients and clients appropriately.
- viii. Facilitating patients' admission and initiating discharge plans.
- ix. Maintaining records on patients'/clients health condition and care.

# 8. REGISTERED NURSE III – TWENTY (20) POSTS - (JOB GROUP CPSB 11)

This is an entry and training grade for this cadre. An officer at this level will work under supervision and guidance of an experienced officer. Specific duties will include:

- i. Assessing, planning, implementing nursing interventions and evaluating patient's outcomes
- ii. Providing appropriate healthcare services including integrated management of childhood illness (IMCI), family planning, immunization, PMTCT, Ante-Natal Care and delivery.
- iii. Providing health education and counselling to patients/clients and community on identified health needs.
- iv. Referring patients and clients appropriately.
- v. Facilitating patients' admission and initiating discharge plans.
- vi. Maintaining records on patients'/clients health condition and care.
- vii. Ensuring a tidy and safe clinical environment; and collecting and compiling data.

### 9. CLINICAL PSYCHOLOGISTS - FOUR (4) POSTS - (JOB GROUP CPSB 09)

For appointment to this grade, a candidate must:

- i. Be a holder of a Bachelor's Degree in Psychology from an institution recognized in Kenya, Master's Degree will be an added advantage.
- ii. Be recognised and registered by the relevant professional bodies
- iii. Have a minimum of two years' experience.
- iv. Have in depth understanding of management of common mental health conditions both inpatient and outpatient care.
- v. Satisfy the requirements of Chapter 6 of the Constitution of Kenya

- ii. Provision of psychology and mental health services to patients in the inpatient department using current guidelines and protocols.

- iii. Provision of psychological assessment and services to staff
- iv. Giving continuous medical education on a regular basis.
- v. Undertake requisite professional development activities
- vi. Performing any other duties delegated by your respective supervisor.

# 10. CLINICAL OFFICER (ANAESTHETISTS)- FOUR (4) POSTS - (JOB GROUP CPSB 09)

For appointment to this grade, a candidate must:

- ii. Be a holder of Diploma in Clinical Medicine Surgery or Clinical Medicine & Community Health or an equivalent qualification from a recognized institution;

- iv. Possess a Certificate of Registration from the Clinical Officers' Council;
- v. Possess a valid practicing license
- vi. Must have good inter-personal and communication skills;
- vii. Satisfy the requirements of Chapter 6 of the Constitution of Kenya.

- i. Offering specialized anaesthesia services
- ii. Responsible for the theatre and ICU management of patients.
- iii. Sensitizing patients and clients on preventive and promotive health;
- iv. Coaching and mentoring students on attachment;
- v. Any other duty as may be assigned from time to time.

# 11. NURSE ANAESTHETISTS - TWO (2) POSTS - (JOB GROUP CPSB 09)

For appointment to this grade, a candidate must:

- i. Be a holder of a Diploma in any of the following disciplines: Kenya Registered Community Health Nursing, Kenya Registered Nursing, Kenya Registered Midwifery from a recognized institution
- ii. Be a holder of a Higher Diploma in Anaesthesia from a recognized institution
- iii. Possess a Registration Certificate from the Nursing Council of Kenya
- iv. Possess a valid practicing license as a nurse anaesthetist

- iv. Clinical support functions to patients.

- viii. Implementing vector, vermin and rodent control measures and
- ix. Implementing integrated mosquito control strategies

#### 13. PUBLIC HEALTH OFFICER - FOUR (4) POSTS - (JOB GROUP CPSB 09)

- i. Be a holder of a Bachelor's Degree in Environmental Health or Public Health from a recognized institution
- ii. Possess a certificate of competence from the Association of Public Health officers
- iii. Be registered by APHOTEC Valid registration certificate

- iii. Assessing health needs of the community
- iv. Implementing sanitation and hygiene standards in the community.
- v. Sensitizing communities on food and water safety measures and
- vi. Compiling data on disease trends
